RECOMMENDATIONS FOR USE

In irrigation systems, use at a rate of 1-10 ppm while irrigating, based on hardness of water. Use higher rate as the hardness increases.

1 ppm	.128oz/1000 gallons of water
3 ppm	.384oz/1000 gallons of water
6 ppm	.768oz/1000 gallons of water
10 ppm	1.28oz/1000 gallons of water

Note: Not to be applied with pesticides.
